Board Elections

The Board shall consist of seven members serving four-year, staggered terms. No person shall be eligible to be a Board member who is not at the time of election a resident and qualified voter of the district zone from which elected.

The district shall be divided into seven zones. The zones shall be numbered and candidates for Board positions shall be listed by the zone number(s) where there is a vacancy. There will be two Board members representing Independence, zones 1 and 2; three Board members representing Monmouth, zones 3, 4 and 5; one Board member representing those rural areas north of Monmouth and Independence and the Monmouth-Falls City Highway; and one Board member representing the rural areas south of Monmouth and Independence and south of the Monmouth-Falls City Highway.

Position Zone Description

| No. 1 | That portion of the city of Independence, north of Monmouth Street extended. |
| No. 2 | That portion of the city of Independence, south of Monmouth Street extended. |
| No. 3 | That portion of the city of Monmouth east of Pacific Highway. |
| No. 4 | That portion of the city of Monmouth west of Pacific Highway, north of Jackson Street. |
| No. 5 | That portion of the city of Monmouth west of Pacific Highway, south of Jackson Street. |
| No. 6 | That portion of the district in Polk County outside of the cities of Monmouth and Independence and north of Monmouth and Independence and the Monmouth-Falls City State Highway. |
| No. 7 | The portion of the district consisting of (1) that portion in Marion County, (2) that portion in Benton County, and (3) that portion of the district in Polk County outside of the cities of Monmouth and Independence and south of the Monmouth-Falls City State Highway. |
