## **District Curriculum**

### **Required District Curriculum**

Within the context of district philosophy, required curriculum is defined as those goals and specific objectives which a student should meet at appropriate levels of development to function effectively as a human being and as a member of society.

It will be the responsibility of every school in District 4J to implement the board-adopted required curriculum at appropriate levels by offering programs which include the state-mandated essential learning skills and clearly stated goals, objectives, and expected student outcomes. Schools must also implement any other state-required curriculum or program requirements.

The administration is responsible for the planning, coordination, and implementation of district curriculum. The superintendent is responsible for establishing procedures to implement this policy.

### **Required Support Services – Guidance and Counseling Program**

It will be the responsibility of every school in District 4J to implement the board-adopted goals and objectives in guidance and counseling. The program will consist of activities and experiences directed toward the development of the following student outcomes:

- Developing decision-making skills;
- Obtaining information about self;
- Understanding opportunities and alternatives in the educational program;
- Setting career and educational goals;
- Accepting increasing responsibility for one's actions;
- Utilizing school and community resources.

The superintendent is responsible for establishing procedures to implement this policy.

### **Required Support Services – Media Services**

It will be the responsibility of every school in District 4J to implement the board-adopted program goals and objectives for a media center. The center will serve as the building's central source for materials and information and will provide experiences directed toward the development of the following student outcomes:

- Locating, selecting and using appropriate media resources as a component of the instructional and guidance programs;

- Demonstrating recognition that media resources contribute to lifelong learning and recreation.

The superintendent is responsible for establishing procedures to implement this policy.

### **Infectious Disease**

Consistent with OAR 581-022-1440, the school district shall maintain an age-appropriate plan of instruction about infectious diseases, including HIV/AIDS<sup>1</sup> and Hepatitis B, as an integral part of its health education curriculum. The plan of instruction will be updated regularly and reviewed by parents, teachers, administrators, community representatives, and persons from the medical community who are knowledgeable of the latest scientific information.
