- Class I** No Fee (Direct cost(s) to the district shall be paid by the organization)
 School sponsored/connected groups (non-fee), student organizations and parent organizations.
- Class II** Nonprofit, in-district education and recreational groups, school sponsored/connected groups (fee assessed) YMCA or other youth organizations, public agencies, community organizations of civic or service nature. (Refer to classification identification) (Non-profit organizations must report ID number)
- Class III** Private organizations which exist primarily for the benefit of the membership, social clubs, classes individually taught for gain, church services, profit making groups, non-school related activities.
- Class IV** Nonlocal (out-of-district), private interest, commercial/profit making.

- Cost of facility includes monitor unless otherwise noted.
- Class II users using more than one area will be charged as follows:
-\$10 for the first area (regardless of area, unless otherwise noted) and an additional \$5 for each gymnasiums, multipurpose/cafe/commons, library, band room. Classrooms to be charged at \$3 for each additional room.

- All Class III & IV fees listed are per day, regardless of number of hours used.
- All persons serving as monitors must be approved by the district, whether they are paid or not.

CLASS I No Fee

School sponsored/connected groups (non-fee), student organizations and parent organizations: (Direct cost when applicable)

Examples:

- DAC;
- Site Committee;
- School Clubs;
- Parent organizations directly associated with schools.

CLASS II Non-profit, in-district education and recreational groups, school sponsored/connected groups (fee assessed) YMCA or other youth organizations, public agencies, community organizations of civic or service nature: In-district political candidates.

Examples:

- 4H;
- Scouts (like organizations);
- Camp Fire;
- Hunter Safety Classes;
- MHCC-Classes taught in schools;
- Kiwanis;
- Lions;
- Special Olympics;
- YMCA;
- City of Gresham (Park & Recreation);
- Little League/ASA Softball;
- Youth Soccer;
- Adult Leagues (Basketball/Volleyball, etc.);
- Soroptimist International;
- District Alumni Groups

Class III Private organizations which exist primarily for the benefit of the membership, socials clubs, political candidates outside district, classes individually taught for gain, church services, profit making groups, non-school related activities. (church service rental-not to exceed 6 months)

Class IV Non-local (out-of-district), private interest, commercial/profit making.
