Public Conduct on District Property

No person on district property will:

1. Injure or threaten to injure another;
2. Damage the property of another or of the district;
3. Violate parking regulations;
4. Drive a vehicle in an unsafe manner;
5. Impede, delay or otherwise interfere with the orderly conduct of the district's educational program or any other activity taking place on school property which has been authorized by the Board, superintendent, building principal or other authorized administrator;
6. Enter any portion of district premises at any time for purposes other than those which are lawful and authorized by district officials;
7. Consume, use, possess, conceal, sell, give or deliver drugs, alcoholic beverages;
8. Violate tobacco use laws;
9. Intimidate students or staff or initiate gang activities;
10. Bring any type of weapon on district property;
11. Sell or distribute unauthorized materials;
- [12. Wear, possess, use, distribute, display or sell any clothing, jewelry, emblem, badge, symbol, sign or other things which are evidence of membership or affiliation in any gang. Use speech or commit any act or omission in furtherance of the interests of any gang or gang activity. A "gang" is defined as a group that identifies itself through the use of a name, unique appearance or language including hand signs, claiming of geographical territory or the espousing of a distinctive belief system that frequently results in criminal activity;]
13. Willfully violate policies, rules and regulations adopted by the Board designed to maintain public order on district property.

Persons having no legitimate purpose or business on district property or violating or threatening to violate the above rules may be asked to leave or removed from the premises and/or referred to law enforcement officials.
