Board Elections

1. Number of Directors

The Board shall consist of seven members elected from zones. The term of office shall be four years. At the discretion of the Board, one or two Board members may be elected at large.

2. Designation of Board Zones and Positions

Board members' positions and their respective successors in office shall be designated as follows:

Zone 1, Position 5
Zone 2, Position 3
Zone 3, Position 7
Zone 4, Position 4
Zone 5, Position 1
At Large/Position 2
At Large/Position 6

In all proceedings for the nomination or election of candidates for or to the office of Board member, every petition for nomination, declaration of candidacy, certificate of nomination, ballot or other document used in connection with the nomination or election shall state the zone/position number or at large/position number to which the candidate aspires.

Individuals may seek more than one elected position such as school Board and education service district Board.

Reelections for Board zone/position will occur as follows:

Zone 1, Position 5: Spring 2015, and every four years thereafter;
Zone 2, Position 3: Spring 2017, and every four years thereafter;
Zone 3, Position 7: Spring 2015, and every four years thereafter;
Zone 4, Position 4: Spring 2017, and every four years thereafter;
Zone 5, Position 1: Spring 2017, and every four years thereafter;
At Large/Position 6: Spring 2015, and every four years thereafter;
At Large/Position 2: Spring 2017, and every four years thereafter.

3. Non-voting Advisory Members

The Board may appoint additional members to serve as non-voting advisory members to the Board. At the time of appointment, the Board shall determine the length of the term. Non-voting members shall not participate in executive session unless invited by the Board.
