Communicable Diseases

MESD shall provide reasonable protection against the risk of exposure to communicable disease for the staff and students served by MESD programs.

Protection from communicable disease generally shall be through immunization requirements, exclusion of students with communicable diseases, or other measures provided for by Oregon Revised Statutes, Oregon Administrative Rules, the State Health Division or the County Health Department.

MESD will follow both the state and local health authorities' rules and regulations pertaining to communicable diseases.

Services generally shall not be provided to students who have been excluded for reasons of communicable disease unless otherwise required by law.

Where MESD knows that a student enrolled in an MESD-operated classroom has been diagnosed by a licensed health care provider with any restrictable communicable disease as defined by Oregon Administrative Rules OAR 333-019-0010., and confirmed by the county health officer as having such communicable disease, MESD may provide an educational program in an alternative setting. A student shall continue in the alternative setting, if provided, until such time that:

1. MESD determines that communicable disease restrictions can be removed by any means provided for by Oregon Administrative Rule OAR 333-019-0014; or
2. The student is ordered to be returned to the classroom by a court or other authority of competent jurisdiction.

MESD shall protect the confidentiality of each student's health condition/record in accordance with federal and state laws and regulations.
