Student Policies, Goals and Objectives

Any student enrolled in an MESD program by a component district is a resident of that component district and is the legal responsibility of such district.

One of the MESD educational program's main tasks shall be to assist each student in becoming self-sufficient and responsible in problem-solving and decision-making. Each student shall be considered an individual.

Staff members shall guide and counsel students in the learning process. The Board and staff shall work together to provide an environment that supports the physical and cognitive growth and development of students by meeting the following goals:

1. Individualize the instructional program with an emphasis on the basic skills;
2. Protect and observe the legal rights of students;
3. Build each student's self-image through positive reinforcement and success-orientated activities;
4. Provide an environment of responsibility in which students can learn personal and civic duties;
5. Deal with students fairly and consistently in discipline matters;
6. Provide for the student's safety, health and welfare;
7. Promote faithful attendance and quality work;
8. Support students' academic growth beyond proficiency in academic content standards; and
9. Encourage their attainment of individual goals.

MESD shall keep the component district apprised of the student's progress and maintain necessary records.

MESD shall forward attendance records needed by the component district to claim State School Fund monies for students enrolled in MESD-operated classrooms.
