

## Diplomas and Certificates of Attendance

### 8th Grade Completion Recognition

The district schools will not conduct an official elementary school graduation exercise. A district-sponsored 8th Grade Recognition Ceremony will be conducted under the following conditions:

1. The district will not furnish diplomas, athletic awards, etc.;
2. The exchange of gifts at the exercise is to be discouraged;
3. The students will not be required to purchase additional or new clothes for the exercise.

A student will not be allowed to participate in a Pine Eagle High School graduation ceremony as a graduate unless that student has fully completed all Oregon and district requirements or equivalency for graduation as listed in Board policy and state regulations.

In addition to credit requirements, as outlined in OAR 581-022-1130, a student must:

1. Demonstrate proficiency in essential learning skills of read and comprehend a variety of text, write clearly and accurately, apply math;

2. Develop an education plan and build an education profile;
3. Demonstrate extended application through a collection of evidence by successfully complete a senior project and presentation;
4. Participate in career-related learning experiences.

The district shall offer students credit options provided the method for obtaining such credit is described in the student's personal education plan and the credit is earned by meeting requirements described in OAR 581-022-1131.

### **Essential Skills Appeal**

The district will follow Board policy KL - Public Complaints in the event of an appeal for the denial of a diploma based on the Essential Skills graduation requirement. The district will retain student work samples and student performance data to ensure that sufficient evidence is available in the event of an appeal.

### **Modified Diploma**

A modified diploma will be awarded to students who have demonstrated the inability to meet the full set of academic standards established by the State Board of Education for a diploma while receiving reasonable modifications and accommodations. A modified diploma may only be awarded to a student who meets the eligibility criteria listed below:

1. Have a documented history of an inability to maintain grade level achievement due to significant learning and instructional barriers; or
2. Have a documented history of a medical condition that creates a barrier to achievement.
3. Having met the above eligibility criteria, a modified diploma will be awarded to students who, while in grade nine through completion of high school, complete 24 credits which shall include:
  - a. Three credits in English;
  - b. Two credits in mathematics;
  - c. Two credits in science;
  - d. Two credits in social sciences;
  - e. One credit in health;
  - f. One credit in physical education; and
  - g. One credit in career technology, the arts or a second language.;
  - h. 12 credits of electives;
  - i. Demonstrate proficiency in essential learning skills of read and comprehend a variety of text, write clearly and accurately, apply math;
  - j. Develop an education plan and build an education profile; and
  - k. Demonstrate extended application through a collection of evidence by successfully complete a senior project and presentation.

District may make modifications to the assessment for students who seek a modified diploma when the following conditions are met:

1. For a student on individualized education program (IEP)'s, any modifications to work samples must be consistent with the requirements established in the IEP. Modifications are changes to the achievement level, construct, or measured outcome of an assessment. This means that IEP or school teams responsible for approving modifications for a student's assessment may adjust the administration of the assessment and/or the assessment's achievement standard.
2. For a student not on IEP's, any modifications to work samples must have been provided to the student during his/her instruction in the content area to be assessed, and in the year in which the student is being assessed and modifications must be approved by the school team that is responsible for monitoring the student's progress toward the modified diploma.

Students not on an IEP or a 504 Plan may not receive a modified assessment.

A student's school team shall decide that a student should work toward a modified diploma no earlier than the end of grade six and no later than two years before the student's anticipated exit from high school.

A student's school team may decide to revise a modified diploma decision.

A student's school team may decide that a student who was not previously working towards a modified diploma should work towards one when the student is less than two years from anticipated exit from high school if the documented history has changed.

### **Extended Diploma**

An extended diploma will be awarded to students who have demonstrated the inability to meet the full set of academic content standards for a diploma while receiving modifications and accommodations. To be eligible for an extended diploma, a student must:

1. While in grade nine through completion of high school, complete 12 credits, which may not include more than six credits in a self-contained special education classroom and will include:
  - a. Two credits of mathematics;
  - b. Two credits of English;
  - c. Two credits of science;
  - d. Three credits of history, geography, economics or civics;
  - e. One credit of health;
  - f. One credit of physical education; and
  - g. One credit of the arts or a world language.
2. Have a documented history of:
  - a. An inability to maintain grade level achievement due to significant learning and instructional barriers;
  - b. A medical condition that creates a barrier to achievement; or

- c. A change in the student's ability to participate in grade level activities as a result of a serious illness or injury that occurred after grade eight.

### **Alternative Certificates**

Alternative certificates will be awarded to students who does not satisfy the requirements for a diploma, modified diploma or extended diploma if the students meets minimum credit requirements established by the district. Alternative certificates will be awarded based on individual student's needs and achievement.

### **Assessment**

Students may opt-out of the Smarter Balanced or alternate Oregon Extended Assessment by completing the Oregon Department of Education's Opt-out Form<sup>1</sup> and submitting the form to the district.
