Confirmation of Residency Application Guidelines

Confirmation of Residency Applications are considered for students who are unable to live with their custodial parent(s) or guardian(s) and are residing with an established residency within the Pleasant Hill School District boundaries.

The Confirmation of Residency Application from must be filled out and signed by the custodial parent/guardian in the presence of a licensed notary and must be accompanied by a notarized Power of Attorney. The Confirmation of Residency Application from and Powder of Attorney must be renewed every six months. The Confirmation of Residency Application can be removed if the school district does not have a valid Power of Attorney on file.

The student must live daily at the residence located with the Pleasant Hill School District boundaries. The person with whom the student will reside must be over 21 years of age.

Students attending a Pleasant Hill school on an approved Confirmation of Residency Application are subject to the same rights and responsibilities which apply to all students in Pleasant Hill School District No. 1 as described in the Student Responsibilities and Rights Handbook.

Confirmation of Residency Applications may be denied for the following reasons:

- 1. Application is made solely for the purpose of participation in interscholastic activities at the receiving school.
- 2. Application is made solely for the purpose of attending a Pleasant Hill School District program.
- 3. Student has only part-time residency in the Pleasant Hill School District attendance area.
- 4. Failure to secure a notarized Power of Attorney form.
- 5. Student's resident district procedures proof the student resident at the named location.
- 6. Lack of availability of space, resources, personnel, or appropriate programs.
- 7. Unfavorable review of the student's education records.
