Public Conduct on District Property

With respect to Policy KGB Public Conduct on District Property, no person, including students, staff, members of the public or community members will engage in uncivil conduct as defined in Siuslaw School District policies.

With regards to extracurricular events and activities, penalties, up to and including criminal trespass from district grounds may be imposed.

Penalties

When individuals will not abide by the basic civility rules during extracurricular events, based upon their behavior, administrators and/or activity supervisors may impose corrective actions or penalties onto student or adult spectators. These penalties may include, but are not limited to:

1. Course work related to sportsmanship and the role of the spectator.
2. Immediate expulsion from the event or contest.
3. Suspension from a specified number of events or contests.
4. Criminal trespass from all district property and events or contests for egregious actions or repeat offenses.

An ejection ‘red card’ will be presented to those individuals whose behavior is unacceptable in an educational environment as they have harassed or menaced students, staff, officials or other patrons of the districts by their actions during events or contests. The authority to eject individuals from school related events, both on and off campus, is derived from the Oregon Revised Statutes; specifically, ORS 164.425 and ORS 164.205.

CRIMINAL TRESPASS NOTICE
You have been directed to leave Siuslaw School District property and not return to any school property including the location where you have received this notice. If you fail to leave as directed or if you return without authorization, for any reason, you will be subject to prosecution. Violators will be prosecuted to the full extent of the law. To discuss this trespass notice, call the office of the school from which the trespass notice originated and schedule a time to speak with a building administrator.

Front of “Red Card”

<p><u>Oregon Revised Statue 164.425</u> (1) A person commits the crime of criminal trespass in the second degree if the person enters or remains unlawfully in a motor vehicle or in or upon premises. (2) Criminal trespass in the second degree is a Class C misdemeanor.</p> <p><u>Oregon Revised Statue 164.205</u> (3) “Enter or remain unlawfully” means: (a) To enter or remain in or upon premises when the premises, at the time of such entry or remaining, are not open to the public or when the entrant is not otherwise licensed or privileged to do so; (b) To fail to leave premises that are open to the public after being lawfully directed to do so by the person in charge; (c) To enter premises that are open to the public after being lawfully directed not to enter the premises; or (d) To enter or remain in a motor vehicle when the entrant is not authorized to do so.</p>

Back of “Red Card”

This administrative rule seeks to promote a school culture of respect and civility. Severe or persistent acts of uncivil conduct may, however, violate other school rules, such as the district’s policies against harassment and sexual harassment or specific conduct codes. Violation of such policies may result in further action, such as discipline, adverse employment action or criminal charges, as applicable. Nothing in this policy is intended to interfere with the ability of school officials to maintain order and discipline in the schools or to enforce school rules and applicable laws.
