## Classified Staff/Classified Staff Positions

The Board recognizes that it is vital to the successful operation of the district that classified staff positions be filled with qualified and competent personnel.

The Superintendent shall approve the employment, fix the compensation and establish the term of employment for each person employed by the ESD to fill classified positions. Candidates for employment shall be recommended to the superintendent by appropriate administrative staff members.

Any candidate who is hired and who is subsequently determined to have misrepresented facts material to his/her qualifications for employment or material to the determination of salary may be subject to dismissal.

The Superintendent will develop administrative regulations as necessary for the recruitment, screening and employment of candidates.
